### STATEMENT UNDER THE UK MODERN SLAVERY ACT 2015

### FINANCIAL YEAR ENDING 31 DECEMBER 2022

Sonatrach Gas Marketing UK Limited (“**SGM UK**”) does not tolerate modern slavery or human trafficking.

The statement below sets out the steps that SGM UK has taken to eliminate, as far as possible, the risk of modern slavery and human trafficking taking place in our organisation and in our supply chains.

#### **SGM UK STRUCTURE**

SGM UK is a trading company in the natural gas sector in the United Kingdom. We are a part of the Sonatrach group (“**Group**”) and our ultimate parent company, Sonatrach S.p.A., has its head office in Algeria. The Group has over 200,000 employees worldwide and operates in 15 countries.

#### **OUR SUPPLY CHAINS**

Our supply chains include producers and traders of liquefied natural gas, providers of regasification capacity, suppliers and distributors of equipment and third-party providers of consultancy services.

#### **OUR POLICIES ON SLAVERY AND HUMAN TRAFFICKING**

We have internal policies which set out our commitment to ensure slavery and human trafficking is not taking place anywhere in our organisation and supply chains.

#### **DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING**

We will continue to implement staff training and awareness sessions to ensure that we:

- identify potential risk areas in our supply chains;
- mitigate the risk of slavery and human trafficking occurring in our supply chains; and
- protect whistle blowers.

#### **SUPPLIER ADHERENCE TO OUR VALUES**

We expect suppliers conducting business with SGM UK to comply with all applicable laws, including the Modern Slavery Act 2015.



## TRAINING

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we will deliver training for our staff.

## OUR EFFECTIVENESS IN COMBATING SLAVERY AND HUMAN TRAFFICKING

To ensure that slavery and human trafficking is not taking place in any part of our business or supply chains:

- we will provide ongoing staff training; and
- we will investigate any reports of modern slavery and human trafficking within our business or supply chains and document what remedial actions are taken in response.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our slavery and human trafficking statement for the financial year ending 2022.
